Updates on land options; status of parcels:

- Discussion at the Land Use Commission about the possibility of the Walker Property for development and/or potential dog park site. A RFP is in process. Mark Selby indicated the Dog Park could put in a proposal. A conceptual design will be needed for the proposal.

Reports on presentations to committees:

- Land Stewardship – Tom Gillispie was unable to attend. He will reach out to the committee for another meeting time if possible.
- Commission on Disabilities – Karen Martin attended and shared the four potential sites being considered. The Commission is in favor of a dog park that is accessible to people with disabilities. Helpful resources and information was provided to the dog park committee regarding accessibility issues for the design plan.
- Healthy Acton – Cathy Foctman attended. A survey is being developed to identify gathering places available or needed in town. The committee will look at the results to see any alignment with the potential dog park.
