1. Ella Campbell lot Mt. Hope Lot 367 Section 3 – Shawn spoke with Ella's daughter and all have come to the following agreement. Shawn has agreed to move the row of flush markers back from the street. The 2 future full interments will go into the lot from left to right, and the tree will remain. Motion made to accept the resolution; seconded; passed.

Mr. Tidman will email the petitioners with information and an invitation to the May 13th meeting to address any questions concerning the October 31st and November 1st performances.

Dear Cemetery Commission Chairperson,

The Acton-Boxborough Regional High School's award-winning Proscenium Circus drama program is planning to produce the play *Our Town* by Thornton Wilder in the fall of 2009. The play is considered a great American classic and will be directed by Dr. Maureen Shea, one of the finest directors in the Boston area. For eleven years, Dr. Shea served as chairperson for the Theatre Department at Emerson College in Boston, and is now a Professor of Theatre at Emerson College. Linda Potter, Proscenium Circus advisor, will be serving as executive producer for the production and I, James Sheehan, will be producing the play.

Our Town is normally set in Grover's Corners, New Hampshire, a fictional town based on Peterborough, Dublin, Jaffrey, and several other towns in the New Hampshire Monadnock Region. However, Dr. Shea would like to base the play in Acton, circa 1901, as there are many similarities between the two towns.

In order to fully conceive Dr. Shea's vision for the show, she would like to set Act II and Act III in Acton's Woodlawn Cemetery and in the adjacent stone chapel. The show would be performed five times, but we would only transport the audience for one or two matinee performances, currently scheduled for Saturday, October 31 and Sunday, November 1 at 2:00pm. She feels that it would be a very powerful experience for many people, especially for those who have lost loved ones in the past.

The audience would be transported via the Acton-Boxborough school bus service from the Acton-Boxborough Regional High School to the cemetery during the intermission, which would occur between Act I and Act II. The audience would then be transported back to the high school by bus at the end of the play. It is estimated that there would be anywhere between 200 and 400 people in attendance at the show each day, and the staff and I would work with you to make this happen, if you believe this is possible.

Linda Potter and I will be meeting in Boston with Dr. Shea this coming Friday, April 10, so it

would be much appreciated if we could have some more information by then.
