I. Minutes of 3/22/07 were approved as written.

II. Award Letters

Members reviewed and discussed the draft Award Letters for each CPA project. The letters were based on last year's format.

1. Groener Land – OK
2. Granite St. Markers
Applicant needs to meet Dept. of Interior standards and the approval of the Historical Commission for the appropriate restoration techniques
3. Archeological Survey – OK
4. East Acton Village Green
Consult with Historical Commission when developing project scope to consider digging restrictions near the foundation, limited to 1 foot deep digging near foundation. Tighten up language in regard to \$30,000 private donations. \$30,000 needs to be secured and utilized before the CPA funds can be spent.
5. Bruce Freeman Rail Trail – OK
6. High School Athletic Fields lighting
Reword section that references zoning bylaw and no need for special permit. Add language in regard to 25 year maintenance contract.
7. Community Housing Program Fund – OK
8. Acton Housing Authority – Support Services
Added requirement that AHA Director should consult with Jean Fleming of COA and Nursing Service just to give another set of eyes to the use of the funds, their approval not required. A report on how the funds were used is requested.
9. Acton Housing Authority – Capital Fund
Make wording for eligible projects more flexible, listing categories instead of specific uses. Must meet Dept. of Interior standards if any of the work is done on an identified historic resource such as Concord Rd. property owned by AHA.

Members should review and contact their assigned applicants for an update on projects from 2004 through 2006. Submit updates to Susan.

IV. Membership status
