Charles Caron from Caron Environmental Consulting reviewed the amended plan and Blanding's Turtle Nesting Habitat Management Plan as approved by the Natural Heritage Endangered Species Program (NHESP) on 12/14/07.

8:07 Certificate of Compliance - 88 Willow Street - S. Bajwa – 85-836 (020)

Ms. Portante moved that the Commission issue a Certificate of Compliance with Special Condition #7 of the Wetland Protection Bylaw Order of Conditions remaining in perpetuity (7. *Mowing/clearing activities within the Riverfront Area of the site shall be prohibited between March 1 and August 1.*)

Ms. Lee 2<sup>nd</sup>; unanimous.

8:08 Certificate of Compliance - 60 Powdermill Road - Autoplex II, LLC – 85-962 (021)

Ms. Lee moved that the Commission issue a Certificate of Compliance for the Order of Conditions issued for the construction of the five-foot wide walkway. Ms. Portante 2<sup>nd</sup>; unanimous.

Emergency Certification - 81 River Street - Lothrop Mill LLC

Staff reported that a portion of the existing building collapsed into the riverbank due to heavy snow and rain. The Emergency Certification is for the demolition and removal of the collapsed portion of old existing building from the river bank. The cleanup should be completed by January 10, 2008; a NOI for the proposed redevelopment of the site will be filed in the near future.

Ms. Portante moved that the Commission issue the Emergency Certification as requested. Ms. Lee 2<sup>nd</sup>; unanimous.
