### AUDUBON HILL NORTH AND SOUTH CONDOMINIUMS – SEPTIC SYSTEM

Steve Ledoux updated the Board on the proposal to amend the lease documents by having the Town pay a yearly fee that the condominium association so they can establish a Capital Fund. We would no longer be required to pay for future capital improvements. As part of the agreement, if we want to tie into sewer in the future, the North and South Associations would grant us the necessary easements.




