There have been 165 views since the initial presentation. There was discussion about outreach to High School faculty, possibly at a Professional Development Day. AML & LWV are doing book groups reading the Stacy Shiff book about Sam Adams and the Committees of Correspondence. The next speaker in the 250 series will be John Adelman on January 30 in the Faulkner Room discussion his book Revolutionary Networks. Amy Cole will be lead another tour of Acton Center on December 10, at 1:30 PM. There will be a limit of 20 attendees.

December 16 is the 250th anniversary of the Boston Tea Party and 30 libraries will be sponsoring a virtual talk "Steeped in Secrecy".

AML sponsoring a master potter, Richard Hamlin, who will be doing a hands-on pinch pot workshop using colonial techniques. Registration is limited to 20.
