II. New/Special Business

1. PB23-11-Continued Public Hearing – 75 Great Road, Sign Special Permit

Jon Cappetta opened the hearing at 7:45PM

Applicant, Mehmet Sahin of Falcon Sign and Graphics presented revised plans to seek one special permit for the exterior wall sign to be made of materials that is otherwise not permitted. (Plastic)

2. PB23-10-Continued Public Hearing – 40 High Street, Definitive Subdivision

The Applicant requested a continuation. PB23-10 has been continued to 8.28.24.

3. PB24-02- Public Hearing- 738 Main Street (9 Wyndcliff Drive). Definitive Subdivision

Jon Cappetta opened the public hearing at 8:56PM

Robert Melvin of Stamski and McNary updated the board with a proof plan and site development plan showing the dwelling and soil absorption system have been moved out of the 50-foot access and utility easement serving Wyndcliff Drive. He advised of design changes to lot 3, revised property lines, a proposed sidewalk easement and the removal of 53 trees that are labeled on the plan. He noted they are still revising the plan based on feedback from peer reviews, town staff, and residents.

Board Comments:

The Board was concerned with the number of trees being removed and requested the applicant plant more street trees and submit a landscape plan.

Sam Bajwa shared his concern of a possible line of site safety issue on Main Street. Robert Melvin stated that the line of site was being looked at and updated for the next hearing.

Michaela was concerned with water runoff due to slope of shared driveway and asked about the stormwater management system which currently meets all requirements.

Residents' Comments:

Nijan Datar and Devashish Chintamani, Kevin Danoho, Ioannis Vlachos, Wyndcliff Drive residents, voiced their concerns with “spaghetti lots”, the number of trees being removed and possible future water run off problems.
