Ms. Kolb called the meeting to order at 3:05 p.m. with no Board members in physical attendance and broadcast via Zoom virtual meeting platform.

**I. Chair Explains the Rules**

Ms. Kolb read the rules of the remote meeting and conducted a roll call for attendance.

**II. New Business**

**A. Solar Credit Agreement**

Ms. Cronin discussed the need for consultation for our Solar Credit Tax Agreement. As part of the condition of construction, the Housing Authority agreed to apply for Solar Tax Credits. These credits will go to the project and not to the Housing Authority. The Housing Authority consulted with Power Options, our state approved utility vendor, who recommended Leyton for assisting with the application for these tax credits. The cost for Leyton is \$10,000 or 1% of the solar credits, whichever is less. Ms. Cronin is looking for a Board vote authorizing Ms. Bible to sign the agreement with Leyton. A motion was made by Ms. Purohit and seconded by Ms. Baran to:

***Approve the Solar Application Agreement with Leyton as proposed.***

**B. Vote of Substantial Completion for ADA Door Openers at Windsor Green Fish #002100**

Ms. Bible discussed that the ADA Automatic Doors had been completed. Very happy with the service and how quickly it was completed. Ms. Bible is looking for a Board Vote authorizing payment for Final Completion. A motion was made by Ms. Baran and seconded by Ms. Purohit:

***Approve the Final Completion of the Automatic Door Openers at Windsor Village #002100 in the amount of \$1881.60.***
