Description of Proposed work: Installation of gutters and downspouts as described in attached application and attachments

Findings:

1. The governing way is School Street.
2. The porticos of both the front and back entrances of the house are visible from the governing way.
3. Gutters and downspouts are unnecessary to divert precipitation from the porticos.

Approvals/Requirements:

1. The proposed installation of gutters to the roof fascia and downspouts to the corners of the house as depicted in the photos attached to the application is approved.
2. The proposed installation of the gutters and downspouts to the porticos and their respective posts at the front and back entrances is disapproved.
3. The gutters must be half-round as depicted in attachments to the application, colored to match the fascia to the extent possible, and the downspouts must be round and colored to match the color of the house to the extent possible.
4. All materials shall be as described in the application and attachments.

Recommendations:

1. Installation of a straight roof rain diverter on the front entrance portico, pitched higher on the left side against the wall, to divert rain water away from the entrance to the house.
2. Installation of splash blocks at the bottom of the downspouts to divert water away from the house.

When completed, the work outlined above must conform in all particulars to the Application approved on November 18, 2025. The applicant may proceed with the proposed work provided all other approvals have been obtained, including a Building Permit if necessary. This Certificate is valid for work commenced within one year of the date of issuance. An extension or renewal of the Certificate may be granted at the discretion of the Commission. If a property

changes ownership during the time the Certificate is in force, a new owner who wishes to continue the authorized work must apply to have a new Certificate issued in his or her own name.

This Decision only applies to matters within the HDC's jurisdiction. Any action permitted hereunder may still be subject to or require other approval or permits from other governmental boards, agencies or bodies having jurisdiction such as the Building Department, Planning Department, Health Department, Planning Board, Conservation Commission or Zoning Board of Appeals, as the case may be.

Any appeal from this decision, or any part thereof, must be filed, in writing, with the Town Clerk within 20 days of the issuance of this Certificate.
