Minutes

Mr. Hudson moved to approve the minutes of November 14, 2016; Ms. Cousins 2<sup>nd</sup>; unanimous.

Discussion – Natural Gas Alternatives and preparing a greenhouse gas reduction plan

Mr. Berry discussed implementing a plan for the Town as presented by Mr. Jim Synder-Grant, from Acton Green Committee.

Mr. Snyder-Grant gave a presentation on a 3-step carbon/greenhouse gas reduction plan. He shared what he had presented to the Board of Selectmen regarding split system heat pumps as an alternative to natural gas for home owners.

Mr. Hudson discussed mapping out activities and goals with the Green Acton Committee. Board members also suggested inviting the Corey York, DPW Director to a future meeting to discuss the plan.

Discussion - Solar Canopy Proposal - Massachusetts Bay Transportation Authority (MBTA)

Mr. Berry stated the Board of Selectmen (BOS) is discussing this item tonight at their meeting. The Historic District Commission (HDC) opposes the proposed solar canopy at the Railroad Street parking area. The Board briefly discussed the next steps for tracking the solar on buildings, locations and any HDC issues.

The Board placed further discussions of this topic on the next agenda.

Update - Main Street Master Plan

Ms. Cousins stated there is no update at this time, her next master plan committee meeting is January 17<sup>th</sup>.

Ms. Crosby explained and explored the spreadsheets in what information and data is compiled in and discussed imputing information into Portfolio Manager, and converting Mass Energy Insight (MEI) next year.


