TOWN MANAGER'S UPDATE

On March 1st, I introduced the Fiscal Year 2022 Recommended Budget to the Board of Selectmen. This budget is reflective of the goals established by the Board and is responsive to the needs of the community. The FY22 budget includes investments related to infrastructure and public safety, sustainability measures, creating new resources to support diversity and equity efforts, increasing resources to address mental health needs, economic development initiatives, continued funding towards Other Post Employment Benefits (OPEB) liability, and sustaining excellent service levels for residents. We're also providing necessary matching funds to support the Town's effort of seeking a grant to remove the hazardous portions of the dam located on River Street. I am pleased to announce the availability of several new features to improve transparency for residents to learn more about the budget, including enhanced departmental information with performance metrics, enhanced organizational charts, financial analysis, and a new Grant Tracker tool. We are also proud to announce the completion of a comprehensive 10-Year Capital Improvement Plan. This plan, developed from a \$25,000 Commonwealth Community Compact grant in partnership with the UMass Boston Collins Center, contains detailed information about infrastructure and recommended investments over the next ten years based on a townwide needs analysis, and will serve as a roadmap for future investment and be built upon in a long-term planning effort for the organization.

Last month, thanks to the efforts of Deputy Fire Chief Anita Arnum, Health Director Sheryl Ball, Nursing Director Heather York, and several other members of our COVID-19 Response team, the Town held another successful vaccination clinic at the RJ Grey Junior High School. More than 100 Acton residents received their first vaccination dose and will receive their second dose within the next several weeks. We continue to work closely with our regional and state partners to provide additional vaccination resources for the community. Home Modification Loan Program

The Home Modification Loan Program (HMLP) provides 0% interest loans up to \$50,000.00, or \$30,000 for mobile homes, to modify homes of elders and individuals with disabilities. Payments are deferred until the transfer of the property.

The mission is to enable a person with a disability to continue to live in his/her home, be as independent as possible and continue to play an active role in his/her community.

Eligibility Requirements

Loans are available to individual homeowners with incomes of up to 200% of median income.

The program is not based on credit worthiness. With a 0% deferred payment loan, there are no monthly payments and no added monthly financial burden.

New Childcare Subsidy for Income-Eligible Local Families

The Towns of Acton, Boxborough, Littleton, Maynard and Westford have been awarded funds from the Massachusetts Department of Housing and Community Development through a regional CARES ACT Community Development Block Grant Program to provide COVID-specific relief to local communities.

Childcare Subsidies are available for low to moderate-income families in all five towns. Participating families will receive \$3,000 for children preschool aged or younger and \$2,000 for children in Kindergarten to age 13 towards their daycare or after school costs so that parents and guardians may work, go to school or seek employment. Funds will be allocated to income qualified families on a first come, first serve basis by each Town using the income limits below with a maximum award during the grant year not to exceed \$5,000 per child. THIS MONTH IN SUSTAINABILITY

Actonians emit about 10.2 metric tons of carbon dioxide (CO₂) per capita. To put this number into context, this falls somewhere between Somerville and Cambridge, where per capita emissions are 8.2 and 13.8, respectively. Overall, per capita emissions in the U.S. are at 15.5 and the global average is about 4.8. While the context and infrastructure in Acton may be different than Somerville or other parts of the world, there is a lot Actonians can do to reduce their emissions. Here are two actions Actonians can take to “ActOn” Climate:

1. Need a New Car? Consider Going Electric


Just over half of Acton's greenhouse gas (GHG) emissions come from the transportation sector—this is mostly from gas-powered vehicles on the road. The good news is that there are a lot of great choices on the market right now for Electric Vehicles (EVs), which release less GHG per mile driven than gasoline-powered cars and may be more affordable than you think. Combined federal and state tax credits can reduce purchase costs up to \$10,000 and EVs can save as much as \$1,200 per year in fuel costs according to the Department of Energy.

2. Opt-up to Acton Power Choice GREEN


Buildings are the second largest contributor to GHG in Acton. One of the quickest and easiest ways to reduce emissions from this sector is by choosing Acton Power Choice (APC) GREEN, which supports the development of new renewable energy projects right here in New England. APC GREEN offers a fixed electricity supply price through September 2022 and makes it easy for residents or businesses to change program options (or to opt out) at any time and at no cost. The APC program has kept 14.5 million pounds of CO₂ kept out of atmosphere to date!
