Welcoming our new Fire Chief

Congratulations to Anita Arnum on her appointment as Acton Fire Chief on October 13, 2023. Arnum began her career with the Acton Fire Department as a full-time firefighter in 1989. She was promoted to the rank of Lieutenant in January 2012 and named Captain in March 2017. She was named Deputy Chief and Town Emergency Management Director in November 2020. Arnum is a state and nationally registered paramedic, a member of the State Hazmat Response Team, and a member of the Federal Emergency Management Agency's National Search and Rescue System. She is also certified in numerous technical rescue fields, and is qualified as an instructor/trainer in EMS, hazmat, firefighting, and technical rescue. Arnum helped guide the Town of Acton through the COVID-19 pandemic, providing testing,

Plan before you Plant


Plant the right tree in the right place for electric service reliability

Trees and power lines don't mix. When they touch, it can cause everything from power outages, fires and downed lines, to safety hazards for people, wildlife and even the trees themselves. Tree branches too close to power lines must be trimmed, and adequate trimming can't always be done in ways that retain the natural aesthetics of the tree.

Low-growing trees maturing up to 25 feet in height such as crabapple, dogwood, hawthorn, plum, and Japanese maple, can be planted near roadside power lines, in the **Red Zone**.

Medium-sized trees, maturing at heights of 25-45 feet, can be planted between **15 and 30 feet from the power lines**, in the **Yellow Zone**. Such trees include arborvitae, flowering cherry, magnolia, hornbeam, and shadblow.

Large-growing trees, reaching heights of more than 45 feet, should be planted **at least 30 feet from power lines**, in the **Green Zone**. Oak, maple, locust, spruce, and pine are some examples.



Plant Trees in the Proper Zone

Red Zone:


Trees less than 25' high

Trees greater than 45' high



DEPARTMENT OF PUBLIC WORKS/HIGHWAY DIVISION SNOW & ICE MAILBOX REPLACEMENT POLICY

Mailboxes installed in the Town right of way are placed at the owner's risk. Each mailbox installation should be sufficiently solid to withstand snow-clearing efforts by the Town. It is the responsibility of the owner of the mailbox to clear the snow around the mailbox to assure mail delivery by the U.S. Postal Department. If the snow banks are too high to shovel, place a temporary box beside the road until the snow has melted enough to allow access to the mailbox.

The mailbox should be installed, periodically inspected and maintained by the homeowner in accordance with the guidelines provided by the United States Post Office (www.USPS.com). When installing a mailbox choose a suitable location. If you are unsure, check with the postal carrier.

The Town does not replace mailboxes if damaged by snow being discharged by the snowplow. The Town only assumes responsibility if a Town plow comes into contact with the mailbox or post.

The Town does not replace plastic mailboxes. Plastic mailboxes in cold weather become very brittle and are not well-suited to withstand this type of environment. The Town also does not replace mailboxes that are in need of repair due to lack of maintenance, vandalism or have a spike-type support. Homeowners should check the condition of their mailbox and post before the ground freezes and make any necessary repairs. The Town will not be responsible for damage to any mailbox or post if the front of the box extends past the curb line and/or is within 6-inches from the curb line.



The Town will only replace mailboxes if the Town's plow came in contact with a well-maintained mailbox or post. The Highway Division will inspect the reported damage to determine the cause of the damage to the mailbox and/or the post. If it is determined that the damage is a result of the Town plow hitting the mailbox or post, the Town staff will attempt to make the necessary repairs. If the mailbox or post is deemed non-repairable, the homeowner may choose from one of the two options listed below:

- the Town will replace the damaged mailbox and/or post with a standard-style metal mailbox and/or wood post,
- the homeowner may opt to furnish and install their own mailbox and post and the Town will reimburse them up to \$100 towards the replacement.

Mailboxes to be fixed will be put on a list and repaired when the Highway Division is back on a regular schedule and all other weather-related priorities are completed.

A CLAIM should be submitted to the Highway Division immediately following the storm so that they can witness the damage and make their determination. LATE CLAIMS are difficult to verify and will likely be denied since they may not be able to adequately determine the cause of the damage.

ACTON BUSINESS ENERGY EFFICIENCY GRANT PROGRAM

Are you the owner of a business in Acton interested in reducing your energy use while increasing savings? Read to learn more about the Acton Business Energy Efficiency Grant (ABEEG) Program!

ABOUT THE ABEEG PROGRAM

Acton's Select Board approved the use of **ARPA funds** to support **energy efficiency improvements for businesses** as part of the Acton Business and Energy Efficiency Grant (ABEEG) Program.

ABEEG will provide eligible business owners in Acton with reimbursement **grants up to \$2,000** to **mitigate the financial impacts of improving the energy efficiency** of their physical location. The Town will allocate up to \$20,000 for this program.

ABEEG PROCESS

During an audit, energy efficiency experts assess energy use to provide customized recommendations for cost and energy savings. Businesses can work with the official Eversource auditor, AECOM, or with another Mass Save sponsored auditor.

It's important for businesses to **apply for the ABEEG grant BEFORE** making any payment for upgrades. (Review steps 1 & 2!)

Once energy efficiency upgrades are completed, businesses pay the cost in full and then send receipt of payment to the Town for reimbursement of up to \$2,000.

HOW TO APPLY

1 Sign up for an Energy Efficiency Audit

Sign up for a no-cost, no-obligation assessment from an AECOM small business Energy Efficiency Expert at: bit.ly/AuditReg.

2 Apply for Additional Savings

Once you've scheduled or signed up for an audit, apply for additional savings of up to \$2,000 through the Town by filling out the following form: bit.ly/ABEEGapp.

Applications are accepted on a rolling basis until November 25, 2023. Grant awards will be announced in the order that applications were received through December 2023.

COMMUNITY SERVICES

NEED HELP PAYING YOUR ENERGY BILL?

Massachusetts' home energy assistance program (LIHEAP) helps eligible households pay a portion of their winter heating bills. No matter what type of heating source you have, and even if the cost of heat is included in your rent, LIHEAP might be able to help.

Home heating costs during the heating season (November 1, 2023 - April 30, 2024) may be eligible for LIHEAP.

Do I qualify?

- Eligibility for LIHEAP services can vary depending on income, household size, place of residence, and other factors.
- Households must meet 60% of state median income levels.
- The Council on Aging and the Community Services Office can help you determine if you qualify.
- Eligibility and benefit information is available online [here](#).

How does the program work?

Fill out a free application to determine if you are eligible. It doesn't matter if you own or rent - or even if heat is included in the price of the rent - LIHEAP may be able to help.

- The program provides a fixed amount for the cost of your primary source of heat, including (but not limited to) oil, electricity, natural gas, propane, kerosene, wood and coal.
- Payments are made directly to the heating company.


WHAT IS YOUTH MENTAL HEALTH FIRST AID?
